### 2. Call To Order:

Mark Whitney called the meeting to order at 6:00 pm. Mark Whitney read the Antitrust Statement:

### 3. Five Minutes on Safety:

### 4. Approval of Previous Meeting Minutes:

Mark Whitney sent out the final minutes of the August 11, 2022 meeting on October 4, 2022. A motion to approve was made by Sanjeev Kapur and seconded by Aivars Krumins. All approved.

### 5. <u>Treasurer's Report:</u>

Bala Devakottai prepared the Treasurer's Report and reviewed the statement. Year over year is basically the same.

Omnipress fee of \$8267 was paid from the knowledge management fund.

Bala made arrangements with the hotel to better separate the safety and technology teams meeting area for more effective simultaneous meetings. The change was much better.

### 8. 2023 Program and Co-Chair Report

Micheal Smith provided an update on the March 2023 EPC Conference.

- Abstracts will be closing on October 25.
- The plan this year is to follow the CDC guidelines, with the added requirement for proof of vaccination or negative. Checks will be spot checks, not 100% audit
- One day meeting registration will be provided as an option this year for registration.



- Manager Special is under consideration by AIChE to assign different people to different days as a lower cost option to the one day registration.
- Wifi is expected to be part of base offering. Wifi sponsorship will be offered, but there no takers in San Antonio.
- Reception sponsorship will be offered, but there no takers in San Antonio.
- Spot recordings will be done for significant events, such as Keynote Speakers. No EPC sessions are targeted at this time
- Pre-recording will be considered, but strongly discouraged to promote face to face.
- Warp speed will be the AV support
- Sunday night EPC Reception will overlap with AIChE. Same start time of 5 pm, run through 6 :30
- Planning to have 10 sessions in 2023 compared to 11 in 2022.
  - Several areas are without any abstracts, but all areas are actively progressing abstracts offline.
  - Maintenance wants to move from Tuesday or Wednesday.
  - Sanjiv suggested fundamentals on Thursday.
  - Technology fundamentals has been done on Thursday for years past.
- EPC Keynote has been done on Mondays in the past with two short sessions following. Expect a proposal for the EPC Keynote at the next meeting.
