No activity of the committee shall involve the exchange, collection, or dissemination of information among competitors for the purpose of bringing about or attempting to bring about an understanding or agreement, written or oral, formal or informal, express or implied, among competitors, with regard to costs, prices, pricing methods, terms or conditions of sale, distribution, production quotas or other limitations on either the timing or volume of production or sales, or allocation of territories or customers.

**<u>Chair/Co-Chair for 2023 session:</u>** No response received so far from Gerardo on willingness/capability to serve as Session Chair for 2023. Post meeting note: Gerardo cannot attend Spring, will not serve as Session Chair. Andrés volunteered to serve as Session Co-Chair (thanks, Andrés). Preferably a new volunteer will make themselves available. Brandon will follow-up with Gerardo.

Discussion of Potential Topics for 2023 Environmental Session: From list in item 3 of agenda.

- a) These topics are still very relevant and will be for the coming years. Andrés raised question on how subcommittees interact and where papers on these topics should fall. Feedback from the 2022 conference was that attendees desired a more cohesive program with less overlap of topics in co-current sessions (this is on radar of Main Committee and will be part of discussion during scheduling of sessions). Issued raised on how Inflation Reduction Act, SEC sustainability reporting rules, and Supreme Court decision in West Virginia v. EPA will impact ethylene industry. Brandon agreed to pursue topic (renamed as "US approach to regulating GHG emissions").
- b) Rick had followed up with Steve Smith. Steve mentioned that EPA had agreed to reconsider several aspects of the EMACT rule. Tentative timing was action by September 2022 with finalization by June 2023. Steve is willing to present on changes/updates. This would be a "normal" length presentation.
- c) Troy expects data to be available and is still willing to put presentation/paper together on topic.
- d) Andrés has not had discussion with Ghent. It is still summer holiday season for Europe (including Universities). Does not expect an issue for Ghent to produce a paper. Effort will be made to tailor topic to best fit Environmental session.
- e) Brandon had discussion with potential presenter. Raised clarification question on intent of topic. Dan stated that buyers are asking producers for Scope 3 information, wanting to understand how values are passed down chain (cradle to gate), what methods are used to calculate and how choices are made. Jennifer mentioned that ExxonMobil would be willing to help. Brandon will go back to potential presenter to see if they are capable of presenting.

As part of the discussion for (a), the scope/naming of the Environmental Subcommittee was raised. Should we change the name to reflect that the subcommittee deals in broader issues than just regulatory. This will be an agenda item for our next meeting.

**Date for Potential Face to Face:** December 8<sup>th</sup> was decided as the better date for the face-to-face meeting. Without an overabundance of abstracts to choose from it is better to use face-to-face time in deciding order of session. Rick stated that LyondellBasell could potentially host (Mark U. had already offered up Linde's Woodlands office). Final location will be decided as we get closer to date.

- Brandon: Contact potential presenter on "US approach to regulating GHG emissions"
- All: Bring thoughts on subcommittee name change to next meeting
