1.) Hold over from last year: Zhenning (Baker Hughes), impact of feedstock impurities on compressor fouling.

Session Feedback

1.) Mercury from shale gas – Two maps were presented in the past in our sessions (shown below). Neither specifically answers the question on the impact of shale gas on mercury concentrations in natural gas or other products from these fields. For instance, there is some mercury in Eagle Ford condensate. In the past I was under the impression that all wellhead gas was treated for Hg, but someone told me that this is not correct. Most treat, but some do not. Maybe Jay can comment on whether there is enough here to pursue.

2.) Steve described a Nalco presentation given by Sam Lordo to Lyondell on the impact on upstream products. Would Sam Lordo present this topic? (Action Item: Dave Smith to explore.) Dave was also asked to explore whether the presentation could be shared among our subcommittee members.

So, two things to explore are the timing requirements, thus would it be 2016 vs 2017? Also, the Main Committee has to grant permission from EPC? (Mark to explore options through Tom)

4.) Steve will investigate Primary Fractionator Fouling due to contaminants. Steve will check with Chevron.

5.) Dow is doing impurity work on the U of Ghent pilot cracker. Mark will investigate whether Dow will allow it and whether Profeesor van Geem would have something to present. Also, may be something already being prepared for EEPC in October. (Mark)
