 The Safety Subcommittee has been asked by the knowledge management committee to assist in determining topics for future online tutorials. The 1<sup>st</sup> online tutorial will be by Ralph King on embrittlement.

The committee would like to see the next tutorial include an overview to the process safety hazards of the ethylene industry. This could be based on a 2007 paper that covered furnace transient conditions, reactive chemicals, exothermic reactions, ethylene decomposition. This might feed the future tutorials, which might include SIS/SIL, exothermic reactor safety and guidelines, ethylene decomposition, NORM and Mercury.
