

AICHE Southern Regional Student Conference

The Clemson University AIChE student chapter is hosting the AIChE Southern Regional Student Conference on the Clemson campus from March 30 to April 1, 2012. They anticipate upwards of 500 attendees from approximately 30 chemical engineering departments in the Southeast. We have been asked to support by providing judges.

There are three events for judging. These will all be held on Saturday March 31st from 9-11:45 AM at the Madren Conference Center in Clemson. Judges are asked to arrive at 7:30 and will be provided with breakfast and lunch on Saturday. If you wish to stay for the rest of the conference, there will be a \$40 fee (reduced from the normal \$75) and you are asked to register via their website (http://caeff.ces.clemson.edu/aiche_register/index.php). At the time of registration, you will be charged the full \$75, of which you will be reimbursed \$35 at the conference.

Below is an overview of each event:

- -The paper competition gives undergraduate students an opportunity to present papers they have published on their research. These papers are presented to a panel of judges, who grade the papers according to a supplied rubric.
- -The poster competition has posters set up throughout a room for the judges to peruse and the presenters present and available for a 5-10 minute informal presentation at the judges' leisure. The focus is on the poster, but the presenter should be able to supplement the material verbally.
- -Chem E car posters show specifications and test results of student-designed cars and are presented to judges. These posters must receive a specific score in order to allow the teams to continue to the performance round, which is a test of the car to perform a specified task. The set-up and presentation is similar to the poster competition.
