# September Section Meeting: Hot Topics in Oil and Gas Exploration and Development & Introduction to Intellectual Property

This month we will have two presenters from Greenberg Traurig, LLP, speaking on two topics.

Hot Topics in Oil & Gas Exploration and Development will discuss:

- constitutionally and legislatively mandated set-back requirements;
- local authority versus state authority, and
- other contemporary issues impacting oil and gas development in Colorado and around the country.

The second presentation entitled, Introduction to Intellectual Property, will give a brief overview of the legal requirements and the benefits of patents, trade secrets, copyrights and trademarks.

He was also selected by the American Institute of Chemical Engineers (AIChE) to provide online IP training for its chemical engineering members.
