#### Letter from the Chair

It's only been one quarter and already the Local Sections Committee has been very busy. First, the committee welcomed Amanda Scalza from the Virtual Local Section as the Secretary. Then the Grants Subcommittee added Todd Jaco from the St. Louis Section who will assist both Jim Klein (Project Planning) and Karen Bard (Project Planning Grants) in reviewing grant applications.

Also the three operating councils, Societal Impact (SIOC), Chemical Engineering Technology (CTOC), and Career and Education (CEOC) have organized a task force called LS2OC (shorthand for connecting local sections to operating councils) in order to connect the various activities and programs being run by the operating councils and their committees to local section activities and programs where they overlap. For example, SIOC has a committee devoted to strengthening AIChE's K-12 outreach programming while several sections have very strong and robust K-12 outreach programs in their area. Both groups could benefit from collaboration but neither have an efficient means of communicating with each other. Currently the task force is made of representatives from all three operating councils, the LSC, and a few local sections and they have been meeting about once a month since January. I'd like to thank Lane Daley from East Tennessee and Laura Dietsche from Mid-Michigan for their help on this task force.

In addition, the LSC has begun its efforts to improve content on the <u>LSC Resource webpage</u> for local leaders starting with revising the recruitment documentation. Input from various sections ranging in size and location will go into the new recruitment documentation to be useful to any local leader no matter the section they are running. There's been one meeting so far and the volunteers have made a few really good suggestions. It is hoped the task will be completed before the end of the year. Special thanks to the local section volunteers Fernando Aguirre (Dallas Section), Lin Li (Northern California Section), Michelle Piry-Haines (St. Louis Section), and Sonali Bhatnagar (North Jersey Section) for assisting in this effort.

Once the effort to revise the recruitment documentation is finished the LSC will need more section volunteers to provide valuable input for the other resources on the LSC Resource webpage.

Finally, I'd like to encourage all section leaders to attend the regional teleconferences occurring over the next few weeks. The regions have been restructured by size and then by geography in order to make it easier for sections to find common ground with their fellow regional neighbors. The regional calls give you a chance to reach out to other local leaders and the committee about concerns specific to your section as well as share any lessons or advice you've learned as your time as a section leader. If you can't make the call, anyone on your executive committee is welcomed to call in and participate. Please join in and help us strengthen the local section community.

## HIGHLIGHTED LOCAL SECTION – CHICAGO LOCAL SECTION YOUNG PROFESSIONALS GROUP

The Chicago Young Professionals Commtitee (YPC) is one of the most active YP groups in the country. With over 50 young professionals attending events in the past year, we offer numerous opportunities for people under the age of 35 to get involved - to network, increase their professional and technical skills, give back to the community, and have fun. Here is a brief summary of what we do.

#### **Activities**

The Chicago YPC puts on their own events that engage the Young Professional population in Chicago.

#### • Monthly Events & Socials

The Chicago YPC tries to focus on events gearing toward a young professional audience. We have had a tour of a local process safety company, a tour of a local brewery run by a Chemical Engineer, beer brewing and wine tastings, and many other events in the Chicago area.

#### • Professional Development & Local University Involvement

In the past we have had specific meetings and roundtables to discuss events unique to a young professional audience. Such events include international travel and searching for your next job. We have also done outreach events with local universities, including Illinois Institute of Technology and University of Illinois at Chicago, focusing on professional development for undergraduate students.

#### • K-12 Outreach

The Chicago YPC handles many K-12 outreach events for the Chicago section. From the DuPage Area Engineers Week Expo, where schoolchildren of all ages come and learn about what it is to be a Chemical Engineer (The ages can lead to some hilarious interactions), to the Fermilab STEM Career Expo, focusing on high school students interested in college majors, we try to explain how cool Chemical Engineering is. Some demos - including kinetic sand, having kids dress up in PPE and having parents take a picture in front of a poster of a chemical plant, explaining a board of Chemical Engineering and different industries that they can go into - are always included and engaging.

#### • Sports

Usually taking place in January, this is usually our most popular event, and we've got more than 30 people attending in the past.

#### **Organization**

The Chicago YPC exists as an almost completely autonomous subgroup within the Chicago Local Section. We have our own executive policies, a small operating budget, and our own elected board, including a Chair, Vice Chair, Past Chair, Administrator, Webmaster, and Membership and Programming Committees. This gives us the freedom to organize our own events and keep members engaged.

## FEDERAL TAX RETURNS FOR AICHE LOCAL

It is everyone's favorite time of the year, tax season! Below is important information that all local section leaders should take note of. For additional information review the Reporting section of the <u>Resources for Local</u> <u>Section Leaders webpage</u>.

The IRS has recently been mandated by the Pension Protection Act to revoke the tax-exempt status of any organization that fails to file a Form 990, 990-EZ, or 990-N for three consecutive years. A nonprofit that loses its exemption because of failure to file will have to reapply to the IRS for exemption.

Each Local Section must file its own federal tax return. AIChE's fiscal year is the calendar year and the deadline for filing tax returns is **May 15** of the following year (or the 15<sup>th</sup> day of the 5<sup>th</sup> month after your section's fiscal year). AIChE cannot file tax returns on behalf of Locals Sections because AIChE doesn't control the finances of the Local Sections, and Local Section revenues and expenses are not reflected on the national organization's financial statements.

The IRS guidelines for which form to file depend on the group's gross receipts (total amount received from all sources, without subtracting any costs or expenses) for the tax year, as follows:

1. If gross receipts are less than \$50,000, the group must file Form 990-N. This is a simple electronic filing using an "e-postcard" which should only take a few minutes to complete.

2. If gross receipts are between \$50,000 and \$200,000, and total assets are less than \$500,000, the group may file Form 990-EZ.

3. If gross receipts or net assets exceed the limits in (2) above, the group must file Form 990.

Local Sections are also required to file a 990-T if their gross income from unrelated business (gross receipts minus cost of goods sold) is in excess of \$1,000.
