

In reviewing October Newsletters from earlier years, it seems appropriate at this time to announce that the Chicago Section is starting its 46th season having been the first local section of AIChE to organize. The first meeting was held on January 16, 1925 - we will be attending the 302nd meeting of the Chicago Section on October 14.

Your Board of Directors between work and vacations held its first meeting on August 25 to formulate and review plans for the coming year. I would like to fill you in on some of the highlights:

- 1. We plan on trying some different locations for our meetings this year and will be closely watching your response. In October we will be in Lemont, November Evanston, January Chicago IITRI, March Whiting, May Chicago downtown. UNION OIL COMPANY OF CALIFORNIA

Union Oil Company of California, formed 80 years ago in Santa Paula, California, is a fully integrated oil company engaged in exploration, production, transportation, refining, and marketing. The Corporation, chartered on October 17, 1890 as a "union" of three small West Coast independents, is now the 12th largest oil company in the United States, the 28th largest manufacturing company.

Union Oil merged in 1965 with The Pure Oil Company, to create a company of national scope which markets in 40 states. It now markets through 88 wholly subsidiaries, 22 other subsidiaries in which it has a 50 percent or more interest, and through more than 18,000 service stations and other retail outlets.

It has affiliates and subsidiaries operating in Canada, South America, Europe, the Middle East, Far East, Africa, Australia, and Indonesia.

In 1965, after the merger with Pure, Union invested \$1.6-billion in a worldwide search for new oil reserves, and to improve its refineries and service stations for the market of the 1970's. Chicago Refinery represents more than \$200-million of this investment.
