- Abstract: Supporting global efforts to reduce man-made carbon emissions to mitigate the effects of global warming, various clean energy technologies are being deployed as alternatives to fossil-fuel-based energy generation. This transition encompasses a wide range of technologies, including solar photovoltaics (PV), wind turbines, battery energy storage, water electrolysis (for hydrogen), fuel cells, and various biomass conversion processes. In particular, conversion of biomass to produce liquid fuels is seen as a viable approach to decarbonize hard-to-electrify sectors, such as aviation, marine transport, and heavy-duty land transport. In this presentation, Frank Petrocelli will draw upon his own experiences to explore some of the key challenges in implementing novel biomass conversion technologies at commercial scale.
