**OBJECTIVE OF PROGRAM:**

To allow interested high school students to observe chemical engineers in the workplace and gain a better understanding of the field of chemical engineering.

**VISITS TO COMPANIES:**

Visits will take place in the Spring (March, April, May) of 2018. Visits will be arranged by a host chemical engineer of the company to be visited. Visits will typically last a half day.

**QUALIFICATIONS:**

Only high school students ***seriously interested*** in pursuing a career in chemical engineering should apply. Students should be preparing to attend college and have ***excelled in mathematics and science***.

Completing the application ***does not guarantee a visit***. Selections will be made by AIChE and the local companies and will depend on demand, availability, and student qualifications.
