The restaurant is located off S Polk Street/Lancaster Parkway in Pineville, next to the James K Polk House. Tyrian for additional directions. Our meeting begins at 6:15 PM, with dinner at 7:00 PM and the speakers beginning at 8:00 PM.

February 22, 2018 Meeting

Our speakers are Mr. Roger Smith with S & ME in Charlotte and Ms. Maggie Macromber with Charlotte Water. At the sections' request (ok, my request), they have graciously agreed to give a repeat of the paper they presented at WEFTEC this year, "The New Normal-Operating and Maintaining The Mallard Creek Water Reclamation Facility After a PCB Contamination". For those who don't know, in 2015 there was a deliberate discharge of PCB containing oil into the Charlotte sewer system. The resulting detection, investigation and cleanup required extraordinary efforts on the part of Charlotte Water and the cleanup contractors, not the least of which involve operating a wastewater treatment plant that can't be shut down while completing a hazardous material cleanup. This presentation provides an overview of the efforts involved in the cleanup.

Mr. Smith is a Senior Geologist and project Manager in the Environmental Department with S & ME, Inc., here in Charlotte. Roger has over 30 years of varied experience but predominantly specializes in assessment and remediation projects. Mr. Smith is a graduate of Marshall University with post-baccalaureate studies at UNCC. Ms. Macomber has been a Senior Engineer with the wastewater operations group at Charlotte Water for 11 years leading wastewater facility planning, rehabilitation and upgrade project coordination, stormwater NPDES permit program administration and managing special projects like the PCB remediation at two facilities. Ms. Macomber received a bachelor's degree in civil/environmental engineering from Virginia Tech and began her career as a project engineer on large wastewater treatment plant improvement projects in the Carolinas.
