History of the Henry T. Brown Endowment




Established in 1968 at the height of the Civil Rights Movement, the "Task Force on Minority Youth Guidance" paved the path for AIChE's Minority Affairs Committee (MAC), and was the first engineering society to address this need.

"No longer should extensive human resources go untapped because of artificial barriers or poor communicationsparticularly at a time when there is an increasing national need for scientific talents."

—from the committee's first position paper, accepted by the AIChE Council at its Tampa meeting on May 18, 1968

Henry T. Brown

The Henry T. Brown Endowment for the Education of Under-Represented Minority Chemical Engineers is a global effort to promote greater inclusiveness in AIChE and the profession by providing an endowment to support, in perpetuity, the education and training of future minority chemical engineers.



Henry T. Brown is one of the original advocates for minority engineers in AIChE, beginning in 1968. He co-created AIChE's first outreach initiatives for underrepresented engineers, and held the position of AIChE's Minority Affairs Coordinator from 1983 through 2001. He remains a guide and mentor to the committee's leaders and active participants. This endowment is a part of AIChE's efforts to attract and retain the best and the brightest, one of five Doing a World of Good campaign priorities that will advance the chemical engineering profession for decades to come.




Leaders of Diversity




Attracting the Best and the Brightest

The Henry T. Brown Endowment Fund will support, in perpetuity, at least fifteen outstanding minority students every year in their pursuit of chemical engineering excellence.




