Letter from the Chair

The summer season is now upon us! I'm sure many of you are now taking a much deserved rest from section activities over the summer but rest assured your <u>Local Sections Committee</u> is still hard at work to serve you!

As I mentioned in my last letter, there was a joint task force, LS2OC, to help better coordinate efforts of other operating councils (OCs) with local section activities. One suggestion that will be implemented is to have OC representatives listen in on the next round of regional calls this fall. Based on feedback the representatives get from these calls, the operating councils will be able to use it to better shape their programs. It will also give sections a chance to engage certain committees who might have resources available for local sections. In addition, the LSC will have the OCs update the sections on their activities during the LSC general call once per quarter to keep sections in the loop on the goings on within the Institute.

In other news, I'd like to welcome another volunteer to the LSC family, Laura Gimpleson. She'll be heading a LSC subcommittee to review bylaws prior to being reviewed and approved by CEOC. She has an extensive background in working with bylaws for SWE so we really appreciate her stepping up and helping the local sections. She's even written an article in this quarter's newsletter, I would definitely recommend checking it out.

The committee also rolled out in April the New and Reviving Section Grant. This grant is intended to help out sections that are just starting out or have been revitalized but don't have any funds to support their initial activities. The grant will be awarded on a rolling basis, so new or reviving sections that have gotten the greenlight from the

committee and CEOC can apply any time during the year. A big thank you goes to the <u>AIChE Foundation</u> for funding this grant.

Speaking of grants, this past quarter saw a number of sections awarded both the Project Connect Grant and Program Planning Grants. For the Program Planning Grant, Kansas City and Ontario Canada won the award for the last cycle. Kansas City won for their well-organized "Energy R&D: Capture, Permit, Control" speaker series and Ontario won for their new section kick-off meeting. I would like to note that in the future applications like Ontario will be directed to the New and Reviving Section Grant.

For the Project Connect Grant East Tennessee, Maryland, and Rocky Mountain sections won the past quarter's award. East Tennessee won for their workshop "Linking Young Professionals" using the "Everest Challenge" to strengthen teamwork among section YPs, Maryland for their Student Forum with University of Maryland Student Chapter, and Rocky Mountain for their Student Appreciation Night at Colorado School of Mines allowing local high school students and young graduates to network with section members. Congratulations to those winning sections and please remember to fill out your post event summary reports so we can feature them in future newsletters or Chenected.

Of course, the committee is planning to review and improve upon the Annual Report, Shining Star Award, and LSC website resources over the next quarter so be on the lookout for updates during the upcoming summer LSC monthly teleconferences as well as in the next newsletter.

LOCAL SECTION BYLAWS: MORE THAN BYTES OR WORDS

As you decide on next year's local section dues, file the section's 2014 Form 990-N or 990-EZ and select the nominating committee members; don't forget to look at your section's bylaws. Yes your section's bylaws, that document that was submitted to HQ to obtain your charter to become a local section of AIChE and obtain the non-profit tax exempt certificate.

This document is the foundation of your section. Bylaws are the contract between the local section and its members that defines how the section will be organized and managed. If you are audited by the IRS as several other technical societies' local sections have been, the inspecting agent expects the bylaws to reflect how the section operates and must match actual practices. During a few audits, the IRS agent has required modification of various Articles in the local section's bylaws concerning fiscal responsibilities and membership requirements. Failure to meet the agent's expectations could cause the local section to lose its non-profit tax exempt certificate.

The original signed document should be in your section's files and a copy included in the section secretary's handbook or jump drive.

For local sections that can locate a copy of their current bylaws to review, appoint one or two members to verify the document still describes current section operations especially in Article VI: Dues; Article VII: Officers and Directors; Article VIII: Elections and Article X: Standing Committees. Listed below is some but not all the areas that need to be checked for accuracy.

- 1. Does Article VI specify an actual amount for local dues and is that amount correct?
- 2. Does Article VII identify current officer titles and duties?
- 3. Does the bylaws allow for electronic balloting, bylaws amending or use of a service such as Survey Monkey?
- 4. Does Article X identify current active standing committees and their responsibilities?

- 5. Is the reference manual cited in the model bylaws' "Article XII" used by the section or listed in the current bylaws?
- 6. Do the current bylaws match how the section pays its bills and manage its funds?

If the answer to any of these questions is a no or the reviewer notices other discrepancies, then the reviewer needs to prepare a report for the Executive Committee to discuss, accept and begin the amendment process. This process is defined in the bylaws and must be followed to legally amend the bylaws. If the section's bylaws have not been amended in the last 10 years, distribution of the amendments may not allow the use of e-mail and other electronic distribution services. Before the Executive Committee votes on the amendments and after the amendments are approved, a copy must be sent to the Career and Education Operating Council (CEOC) of the Institute for approval.

For local sections that cannot locate a copy of their existing bylaws, compare the 2015 model bylaws to section operations. Note any differences between the model and actual operations. Then have the reviewer prepare a report for the section's Executive Committee to discuss and accept. Once the report is accepted by the Executive Council, the amendment process as defined in the model bylaws is followed to legally amend the bylaws. Before the Executive Committee votes on the amendments and after the amendments are approved, a copy must be sent to the Career and Education Operating Council (CEOC) of the Institute for approval.

Section Bylaws are a living document. They cannot be approved during the formation of the section and forgotten. The document must be amended as the section changes and reflect how the local section operates. Failure to amend the bylaws may not seem important until the IRS or another governmental agency conducts an audit. Then failure to maintain the section's bylaws can be a deathblow to the section.


